## Trip Agreement & Waiver

  - To not bring or use any illegal drugs or substances during the course of the trip (If I break either of these rules, I understand that I will forfeit the rest of my trip and be sent home at my own expense). ( )
2. Due to different cultural standards and health risks involved in traveling to another country, I also agree to the following:
  - I will dress modestly.
  - I will not use profanity or act in a way to cause undue attention to the team.
  - I agree to follow the health and safety precautions as directed by team leaders.
  - I agree to refrain from dating and/or romantic public displays of affection with other team members as well as National PID staff during my trip. ( )

**HOLD HARMLESS/RELEASE AND INDEMNIFICATION AGREEMENT  
RELEASING PARTNERS IN DEVELOPMENT (PID) FROM LIABILITY**

1. **ASSUMPTION OF RISK AND STATEMENT OF HEALTH:** I am fully aware that participating on this trip may contain risks of physical and emotional injury as well as property loss or damage. I am also fully aware that any type of airline travel may involve cancellations or delays. I know and understand the scope, nature, and extent of the risks involved in going on this trip and activities contemplated by this Agreement. I voluntarily and freely choose to incur and assume any and all such risks. I further represent that I am in good health and I have no known physical disabilities or health problems that will present any risk to my participation in the trip. ( )
2. **PERSONAL RESPONSIBILITY:** I will listen and follow all direction and instructions given by PID staff/representatives and trip leaders. I will not, under any circumstance, leave my group without one the trip leaders or PID staff going with me. ( )
3. **EXEMPTION FROM LIABILITY:** I hereby fully and forever voluntarily waive, discharge and release Partners In Development and all agents from any and all liability, claims, demands, actions, and causes of actions whatsoever, both in law and equity, arising out of or in any way resulting from personal, physical, psychological or emotional injuries, distress or death, loss of services, or property damage, allegedly sustained during or from the trip or any of its associated activities. ( )
4. **COVENANT NOT TO SUE:** I hereby voluntarily agree not to institute, initiate, or assist the prosecution of any suit, claim, or action at law or equity, or otherwise, against PID for damages which may occurred from the trip or any of its associated activities. ( )

5. **ARBITRATION AGREEMENT:** I hereby agree that any controversy or claim not effectively released in this Agreement arising out of or relating in any way to my participation on the trip will be determined by submission to arbitration in accordance with the rules of the American Arbitration Association and the laws of the State of Massachusetts, and not by lawsuit or court process (except as applicable laws provide for judicial review of arbitration proceedings). This Agreement includes arbitration of claims made against PID, staff, trip leaders, intentional or otherwise. The decision of the arbitrators may be entered in any court that has jurisdiction of such matters. By signing this, I am agreeing to have any issue or claim arising out of my participation on the trip decided by neutral arbitration and I am giving up my right to a jury or court trial. ( )
6. I understand that this Agreement shall be construed and governed by the laws of the State of Massachusetts, and it cannot be modified unless in writing and signed by both parties. ( )
